Art. 1

ORGANIZATION

STRUCTURE OF THE CORSE

Course is constituted by 6 lessons (2 weekends). Each student will participate to three lessons for weekend, one a day. The duration of each lesson is 40 minutes. The classes are open, students may participate as observers in the lessons.

LESSONS

The classroom will be equipped with a camera that will allow the recording of lessons. Lessons will be posted on youtube (in private form) so that students can review them.
